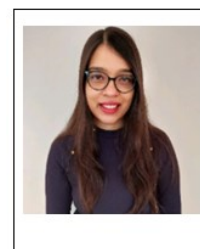


SPEAKER PROFILES

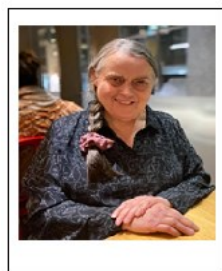

You also may occasionally find him in hiking boots on a trail, or travelling about with a guitar in hand.

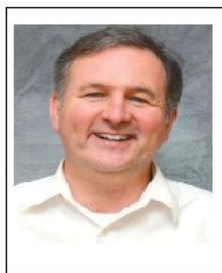

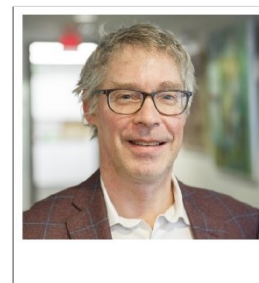
SPEAKER PROFILES
